We are happy to announce the 'TCS NQT' for the YOP 2024 is open.

Below is the timeline for this year's 'TCS NQT' with Integrated Test Pattern.

Recruitment Event: 'TCS NQT FY24 with Integrated Test Pattern'

Last Date for Registration: Wednesday, 10th April 2024

Test Mode: In-Center only (iON Centers)

Detailed Eligibility Criteria for this hiring process.

Request to get the eligible students to complete the "TCS application form" and "apply for the drive" as per timelines.

VERY VERY Important Points:

- 1) Students only from the year of passing batch of 2024 may apply and the same should reflect in their TCS Application Form.
- 2) Students MUST register and complete the TCS Application Form in the TCS NextStep Portal under 'IT' section and finally choose the nearest test center to take-up the integrated assessment.
- 3) All students must ensure that they use their Personal Email ID to register in the TCS NextStep Portal. Email ID CANNOT be changed once submitted.
- 4) Students should fill in the application form correctly, verify the details before submitting and make sure that their status in the TCS NextStep portal is "Applied for Drive". Students can check this by visiting the "Track My Application" tab in the NextStep portal.
- 5) Information retrieved from TCS Application Form will be considered for the test process.
- 6) We would not be able to batch students if their 'TCS Application Form' is incomplete and the candidate status should be "Applied for Drive".

Process to complete the TCS application form is outlined below:-

- Students to visit- <https://www.tcs.com/careers/india/tcs-fresher-hiring-nqt-2024>
- Click on "Register here".
- Choose the category as "IT"
- Fill up the details to generate a Reference ID.
- Proceed to complete the Application Form.
- Finally Choose the nearest test center to take-up the integrated test.

TCS Eligibility Criteria:

- 1) **Courses & Disciplines:** Students from the batch of 2024 with highest qualifications, across all disciplines, departments or streams may apply - Bachelor of Technology (B.Tech.), Bachelor of Engineering (B.E.), Master of Technology (M.Tech.), Master of Engineering (M.E.), Master of Computer Applications (M.C.A), Master of Science (M.Sc. / M.S).
- 2) **Course Types:** Only Full-Time courses will be considered (Part Time / Correspondence Courses will not be considered).
- 3) **NIOS:** Students who have completed their Secondary and / or Senior Secondary course from NIOS (National Institute of Open Schooling) are also eligible to apply if the other courses are full time
- 4) **Percentage:** Minimum 60% or 6 CGPA throughout academics including the highest qualification, till the latest semester for which results have been declared at the time of appearing now for the test process.
If selected, the offer will be valid only if the degree / provisional degree certificate clearly states that the student has cleared Engineering in 'First Class' after completion of the course, at the time of joining.

- 5) Backlogs / Arrears / ATKT: NO backlogs / arrears / ATKT at the time of appearing for the TCS Selection process.
- 6) Gap / Break in Education: It is mandatory to declare academic gaps if any, during the period of education. Break in education should not be due to extended education (examinations cleared after the time stipulated by the Board / University). Any break in education should not exceed 24 months and is permissible only for valid reasons. Relevant document proof, as applicable, will be checked for gaps in education.
- 7) Work Experience: Students with prior work experience of up to two years are eligible to apply for this hiring process (Applicable only for postgraduate students).
- 8) Age: A student should be 18 to 28 years of age to participate in the 'TCS NQT for Priority Institutions'.

- Numerical Ability- 25 Mins
- Verbal ability- 25 Mins
- Reasoning ability- 25 mins

Part B- Advanced Section

- Advanced Quantitative & Reasoning Ability- 25
- Advanced Coding- 90

Total Duration (Part A & B) = 190 mins

NOTE- Advance Coding covers: C, C++, Python, Java & Perl

Compensation offered:

- Category 1st:- Ninja- 3.3 LPA to UG & 3.5 LPA to PG students
- Category 2nd:- Digital- 7.0 LPA to UG & 7.3 LPA to PG students
